Proceedings of the meetings of HSVP officers held on 12.08.2021, at 10.00 A.M of all Zone through Video conference, under the Chairmanship of Sh. Ajit Balaji Joshi, IAS, Chief Administrator, HSVP, Panchkula.

The agenda items were discussed in detail. Item wise deliberations/directions issued are as under:

Agenda item No. 1 & 4:- Status of auction-able properties- i.e. residential, commercial, Institutional & List of Vacant Residential, Commercial and Institutional Plots Industrial Sectors.

The Chief Controller of Finance, HSVP brought to the notice that almost in all the previous meetings held, the Zonal Administrators/Estate Officers were directed to send the list of actionable properties keeping in mind that the E-auction will be conducted on regular basis for next six months but no action has been taken by the concerned. The HQ has to request again and again to the Zonal Administrators/Estate Officers to send the list of auctionable properties. Due to this, there is un-necessarily delay in conducting the E-auction. The Chief Administrator, HSVP has written a D.O. to all the Administrator vide No. 135661-65 dated 04.08.2021 to send the list of vacant residential/commercial and institutional plots in their respective Zones/Urban Estates but the information have not been received.

Further it was also apprised that the industrial Estate developed by HSVP were transferred to HSIIDC alongwith the vacant plots. There might be some vacant plots in the residential, institutional and commercial pockets falling under these Industrial Estates. Chief Administrator, HSVP has written a D.O. dated 09.8.2021 to all the Zonal Administrators to send the list of the vacant plots in these pockets. The requisite information is awaited from all the Zonal Administrators/Estate Officers. The Chief Administrator took a serious view of the same and the following directions were given:-

- 1. All the concerned Zonal Administrator and Estate Officers to send the list of the auctionable properties by $16^{\rm th}$ August 2021 positively.
- 2. The properties sent by the Estate Officer are very few in numbers and EO's should send the more auctionable properties. Keeping in view the facts that two auctions per month for next six month are to be planned.
- 3. The Chief Controller of Finance shall device a proforma in consultation with Sh. Anirudh and circulate to all the concerned for getting the information of auctionable properties online.

The Chief Controller of Finance, HSVP brought to the notice that vide letter No. 130268 dated 27.07.2021, it was requested to all the Administrators to send the list of properties available for e-auction in Transport Nagars, but the information in this regard is still awaited from Karnal, Kaithal and Panipat. Kurukshetra, Sonepat, Bahadurgarh, Rewari and Gurugram-I and II whereas the information received from Estate Officer, Panipat is incomplete.

The W/Chief Administrator took a serious view of the same and directed to all the concerned Zonal Administrator and Estate Officers to send the list of auctionable properties out of the list of Surrenders, Cancelled and Resumed plots alongwith the Base Price and Size, so that same can be put for e-auction by 16th August 2021 Positively.

The Chief Controller of Finance apprised that the total installment recovery amounting to Rs. 5031.95 Crore as installments fee as per PPM against the allottees of residential/commercial/institutional plots of all Zone. In the last meeting the targets were fixed of every estate officer but no one estate officer could achieve the target. The following directions were passed:-

- 4. All Estate Officers will also prepare the list of all properties in which the amount is to be recovered from the Govt. Offices/Corporation and send at the HQ by 20th August, 2021. Sh. Kanwaljit Singh, CAO O/o CCF HSVP will coordinate in Finance Deptt. Haryana for payment of outstanding dues

Agenda Item No. 13:- Review the status of Mutation.

The Chairman expressed his displeasure for not taking effective steps by the Estate Officers for sanctioning of mutations and said that a lot of land have been acquired but has not been got mutated in favour of HSVP. It was also noticed that as per instructions dated 1.12.2020 due to non mutation of land the payment of enhanced compensation have also not been made to the land owners in which directions has been given the payment of enhanced compensation should be made after the land got mutated in favour of HSVP.

The Chief Administrator directed to the Estate Officers to file applications for recording the mutation in favour of HSVP before the D.R.O with in next 15 working days, particularing those awards which have been finalized up to Hon'ble Supreme Court. The Concerned Land Acquisition Officer shall also supply the list to the concerned Estate Officer of that award which have been finalized up to Hon'ble Supreme Court under intimation to the Concerned Zonal Administrator.
