Club Buildings including providing infrastructure facilities namely Plumbing, Internal and External Water Supply, Sewerage, Electrification, Storm Water Drainage, Roads, Parking, Boundary Wall with Gates, Fire Fighting Services, Boundary Wall, RCC jal on duct and External Electrical Services, 100% Power Backup, Parks and Horticulture Works, Roof Top Rain Water Harvesting System, Solar photovoltaic Power plant, Gas Pipe Provisions and any Other Service, if necessary for completion within the premises earmarked for above building blocks including 12 no. 16 Passenger Lift & 6 no. 15 Passenger .
