TERMS AND CONDITIONS FOR HELICOPTER JOY RIDE SPRING FEST-2023.

15.	The successful company/firm/LLP will provide 02 (two) helicopters (minimum 05 seater) one as main and second as standby, for the said ride.
2.	The ticket cost inclusive of GST for per seat be clearly mentioned.
3	The successful company/LLP shall also give the credit of 05% (five percent) per ticket minimum from total sale of tickets to the HARYANA SHEHARI VIKAS PRADHIKARAN (HSVP).
4	The duration of each helicopter ride shall be 07 to 10 minutes.
5	The Agency shall obtain all necessary aviation permissions from all the concerned authorities in time.
6	The deployment of Ambulance and Fire tender at the site to operations shall be mandatory as per DGCA guide lines.
7	The helipad area will be clearly marked by tapes to avoid any unauthorized person entering and the Entry and Exit Pants will be clearly marked separately by the Company. Any coordination required will be provided by the HARYANA SHEHARI VIKAS PRADHIKARAN (HSVP).
8	The dates of Helicopter Joy Ride shall be strictly in tandem with dates of Spring Fest-2023 i.e. 04 th and 05 th March-2023.
9	The circuit pattern (Route Map) will be decided by the HARYANA SHEHAR VIKAS PRADHIKARAN (HSVP). In coordination with the Company to make a safe flying pattern.
10	All flying Operations will be done only under the supervision of the Company as per DGCA guidelines and decision of pilot to operate will be final.
11	No flying operations will be undertaken in bad weather. In the event of bad weather, all the rides of the day will be extended to next operational day provided that no ride will be place after the concluding day of Spring Fest-2023.
12	 i) 02 helicopters with crew. The pilot should be on pay roll of Company/Firm/LLP. ii) Handing staff. iii) Marshals. iv) Windsock.
13	The tickets will be printed in different colour codes to mange crowed in smooth manner. Each ticket will be valid for a particular day and will be timed pre or post lunch to avoid rush, as the flying operations will ceas haryana shehari vikas pradhikaran (HSVP).
