Allotment of Police Station Taraori in Sector-1, Taraori (CM Annoucement Code no. 15560).

This is with reference to the subject cited above.

The matter has been considered & examined. It has been decided to allot land measuring 1.75 acre (appox.)(shown in the part layout cum demarcation plan of sector-1, Taraori Distt. Karnal Drg. No. DTP (K)1450/13 dated 12.09.2013) to the Police Department for construction of Police Station thereon on the following terms and conditions:-

- 1 The land shall be transfer to Police Department free of cost and building of Police Station is to be constructed by Police housing Corporation.
- 2. The site shall not be used for the purpose other than the one for which the land is being allotted. If the land is not used for the specified purpose, it will automatically revert to HUDA along with the structures raised, if any.
- 3. The transfer of ownership of plot, change of land use shall not be allowed under any circumstances. However, the owenership of land shall continue to vest with HUDA.
- 4. The commercial use shall also not be allowed in the allotted area under any circumstances.
- 5. The control over the building shall be exercised through a zoning plan of the site which shall provide for the building zone, maximum permissible ground coverage, maximum permissible height, parking area, type of boundary wall and gate etc. besides specifying the use of plot.
