- Standard Operating System prepared by ULB shall be adopted by HSVP 3. ULB may be requested to provide link of portal i.e. ulbshops.ulbharyana.gov.in.
- CITO, HSVP shall be State Nodal Officer of HSVP. 4. This has the approval of Hon'ble CM-cum-Chairman, HSVP for approval.
